Part 1: General Requirements

In addition to all requirements outlined in the Mexico High School Band Handbook, I agree to:

- 1. Attend all scheduled in-school lessons each quarter OR attend two (2) in-school lessons and at least five (5) lessons with an approved private music teacher each quarter towards my quarterly and overall Weekly Lesson Attendance averages.

- 3. Attend at least 85% of scheduled after school and evening Marching Band rehearsals, which will count towards my quarterly and overall Weekly Participation averages.
